- There is a consensus from the elected Water Race community representatives that the water race rates need to be more affordable.
- CDC currently uses a matrix to allocate support costs between departments / service areas.
- At the last meeting John McFadzean had proposed a model for support costs being fixed at a percentage of gross income e.g 10%.
- A key difference between the water races and CDC service areas is that the water races are privately-owned enterprises, not part of council.

6 **REPORTS**



6.1 WATER RACE REPORT, MAY 2024

1. PURPOSE

To provide the Water Race Committee with an update on the management of the Water Races.

2. WATER RACE RECONSENT APPLICATIONS

The consent application was submitted in May 2023, and the continued operation of the Water Races has been approved by GWRC. Lawrence Stephenson has been continuing with the consent processes:

- This will be a continuation of the gauging started this summer, and more targeted sampling is planned. For instance, a survey of the Carrington water race discharges to the Mangatarere and Enaki in March showed that of the 8 discharge points, 7 were dry.
- The further information request sent in October was responded to at the end of February 2024. This is being considered by the Regional Council. It will be publicly notified, but we are still waiting on timeframes. A discussion with the Regional Council experts is planned to look at what evidence has been gathered and what would be appropriate to be a condition.
- At the moment, a 20-year consent is requested, but we have not had any feedback from the regional council yet.

3. CARRINGTON INTAKE

The high river flows have meant that the replacement of the Carrington Intake has not progressed. The pipeline may be able to be installed now that low flows in the Mangatarere stream are likely. A plan will need to be developed for installation of the intake structure.

4. REQUESTS TO STOP WATER RACE ACCESS

The Council has received a request to remove the water race rates from a property along Cobden Road. The water race will still flow through the property, but it will be fenced and not used.

The recommendation is for this request to be denied because the water race is still available for use (i.e. pumped) and will still require maintenance to maintain the supply to users downstream. The water race can also not be redirected around the property. Refer to **Attachment 2** – Water race rating policy and the section on closure.


It does raise the case that if a water race/tail race could be redirected, is there an agreed process for this to happen?

The team is still working on the process to get the information into the application in a consistent basis.

There have been a couple of requests to install culverts:

 Sharpes on Francis Line – this was discussed with Regional Council as it was mapped as a natural stream, but during a site visit it was agreed that the contours didn't work and it was a water race. The application was approved and will also reduce the risk of contamination entry to that section of water race.

6. OVERSEER'S REPORT

Continued Seasonal Impact

The water race flows have reduced and we are getting long periods of lower flows. The overseer has also noted natural streams drying up this summer which he has never seen dry.

The dry weather has allowed catch-up work to progress after the heavy winter rains which caused overtopping and flooding. The contractor has been catching up installing new culverts after the wet ground conditions which restricted access.

The overseer is having to respond to a number of "no-water" call outs, requiring adjustment of the weirs.

Rubicon was onsite on 23 April to maintain the gates and check the accuracy. It was found that Carrington was over-reading due to the silt buildup around the level sensors.

UPDATED WATER RACE OVERSEER'S REPORT

This report updates the Water Race Overseer's report for February 2024.

There has been very bad weed growth this season, the worst the Water Race Overseer has seen. The growth is very thick and when any is mobilised this weed raft is causing a number of block culverts.

Flushing for the water race during a river fresh had been working well. The season has seen a number of these events at fairly frequent periods. The higher flows have allowed it to flow down the water races towards the ends maintaining decent water and also carried the fish spawn with it. This has been good for fish spawning and has been very beneficial. An inspection by a trout fisherman behind the digger noted plenty of Brown and Rainbow trout spawn and included native fish. The freshes coming through have helped to spread the spawn further washing them into the lower reaches of the network.

Repair work has started on Carrington Hill and slips that resulted after the wet winter.

People are continuing to erect fences and these are causing issues. The fences are frequently installed too far away from the side of the race. The sites which have funding from Greater Wellington Regional Council for fencing have been co-ordinated with the water race overseers, but most are not.

A number of access gates have been hot-wired, without any isolation. These need to allow for the power to be shut-off or a tape that can be lowered easily.

Two or three of the farms where there is no cleaning have relied on just spraying. This is resulting in matter building up and sinking to the bottom. This has reduced the depth of the race, increasing the risk of water overtopping.

Transport costs are getting high around areas with fencing. The number of people requesting this is increasing which is adding extra cost and time. Transporting the vegetation is also causing leakage over the road if it is moved to another farm.




3. UPDATED HISTORIC WATER QUALITY DATA

To view the trends, the charts below cover the full sampling period from 2015 – 2024:


Nitrate levels are generally elevated in winter/spring with the higher flows. The levels are currently less than 11.3 for Drinking Water but this is still high for NZ. The majority of Total Nitrogen is nitrates. Peaks are decreasing.



The E-coli coliforms have a limit of 260 for safe swimming. An improvement in high readings may indicate reduced overland flows.



New freshwater targets of for DRP are less than 0.05.

The financial performance to 31 March 2024 has provided an operating deficit of \$67k compared with a budgeted deficit of \$75k.

Overheads are under budget by \$24k.

Resource consents are under budget this will be due to timing, invoices should be received from GWRC for annual monitoring as part of our resource consents and should be on track by year end.

All other areas are slightly over or under, with nothing unusual to note at 31 March 2024.
