2 REPORTS

4.1 REPRESENTATION REVIEW WORKSHOP

1. PURPOSE

As part of the Representation Review, for Councillors to work through the representation options that will be used for engaging with the community and seeking their feedback.

At the previous workshop council officers were asked to use demographic data to develop representation options for preliminary engagement with the community.

The workable options included 10 possible structures, of which five met, or were close to meeting the requirements set down by the Local Government Commission, in particular the requirement to have an elected member per every 1281 person in Carterton, or within 10 per cent higher or lower of this figure for 8 councillors.

Three of these options were discussed as viable for public feedback. These were:

- Option 1A 8 Councillors, elected "At Large" [representing the entire District].
- Option 2 A 8 Councillors, divided into two wards: one "Urban" [five councillors] and one "Rural" [three Councillors].
- Option 5 A 8 Councillors, divided into one "Urban" Ward, [three councillors] and one "Rural" Ward [two Councillors], plus three "At Large" Councillors.

It is noted that the remuneration for councillors in each council is set by the Remuneration Authority. The full amount must be divided between the councillors and so a reduction in the number of councillors does not provide any savings.

While these options offer the most workable solutions presented, in the preliminary engagement period Council will listen to the feedback from the community on all representation options, including the number of councillors, number of wards, and also whether or not community boards should be established.
